PROBLEMS YOU FACE

- Centralised messaging platforms face increasing regulatory, privacy and censorship risks (for example, even major services' leadership being scrutinised or charged for allowing criminal activity).
- Many messaging systems are not native to Web3: they don't integrate seamless crypto payments or token-based rewards, and user data/control remains in centralized hands.
- Micropayments, tipping, creator monetisation and integrated chatpayments remain fragmented or require leaving the chat interface.
- Users who want privacy + crypto payments + messaging in one package have few good options.

GhostRoom addresses these problems by offering:



Decentralised Messaging on Solana

Utilising Solana for high throughput, low cost transactions ensures messages, calls and payments happen rapidly and cheaply. According to GhostRoom: "Solana is the ideal foundation ... due to its industry-leading transaction speed (up to 65,000 TPS), extremely low fees





In-Chat Crypto Payments & Tipping

GhostRoom integrates payments directly inside conversations: users can send messages, make calls and transfer value—without leaving the chat interface. The x402 protocol (internet-native payments) is referenced as part of the payment stack.



Fair Token Launch and Community Ownership

The native token \$GROOM will be launched via a 100% fair-launch model: no presales, no private allocations, fully open to community participation.





Privacy & Security Focus

GhostRoom emphasises user control of data and assets, leveraging security-centric engineering ("team has over 20 years of combined experience in programming and network security.



Interoperability & Web3 Integration

The platform plans to integrate with DeFi, NFT marketplaces and other Web3 apps—creating a broader ecosystem around messaging, payments and community.

Phase 1

- Website design & development.
- Whitepaper creation.
- Setup of the core messaging framework.

Phase 2

- Roll-out of text and image messaging within GhostRoom.
- Strategic marketing campaigns targeting Solana / cryptonative communities.
- Integration of x402 (Coinbase's internet-native payment protocol) for in-app payments and tipping.



- Large-scale marketing to Web3 audiences.
- Launch of audio & video calling.
- Integration with the broader Solana ecosystem for interoperability.
- Implementation of GhostRoom Pay (crypto payment gateway) powered by x402.
- New UI design, GhostRoom v2 with modular architecture.



Phase 4

- Launch GhostRoom app on Solana Mobile DApp Store.
- Global marketing expansion GhostRoom Ads, influencer collaborations.
- Listing on major centralized exchanges (CEX) for global exposure.
- Launch of group chat / community channels.
- Introduction of streaming feature for real-time content & creator interaction.
- Launch staking & rewards for active users and token holders.
